11. Cautionnement provisoire

Each bidder must include in his administrative documents, a bid bond issued by a first- rate banking establishment approved by the Ministry in charge of finance and whose list is found in document No. 12 of the Tender File, of an amount of 540 000 CFA (five hundred and forty thousand Francs CFA) and valid for thirty (30) days beyond the date of validity of bids.

12. Recevabilité des offres

Under penalty of being rejected, only originals or true copies certified by the issuing service or administrative authorities (Senior Divisional Officer, Divisional Officers must Imperatively be produced in accordance with the Special Regulation of the Invitation to They must obligatorily not be older than three (3) months preceding the date of submission of bids or may be established after the signature of the tender notice Any bid not in compliance with the prescriptions of the Tender File shall be declared inadmissible. This refers especially to the absence of a bid-bond issued by a first-rate bank; approved by the Minister in charge of Finance.

- 8. Financial situation below one third of the estimated cost

B. Essential criteria

- 1. General presentation of the Tender;
- 2. Financial capacity
- 3. References of the company in building construction;
- Quality of the personnel;
 Technical organization of the works;
- 5. Safety measures on the site;
- Logistics;
- Attestation and report of site visit signed by the Contractor;
- 8. Special Technical Clauses initialed on all the pages and signed at the last page;
- 9. Special Administrative Clauses completed and initialed on all the pages and signed at the last page.

15. Attribution

This evaluation will be done in a purely positive way (yes) or

negative (no) with an acceptable minimum of at least 75% of the essential criteria taken in account.

The contract will be awarded to the bidder who would have proposed the offer with the lowest amount, in conformity with the regulations of the Tender Documents and having satisfied to 100% of the eliminatory criteria and at least 75% of the essential criteria.
